

NUTRISOY ONDEH ONDEH X 7E “Win \$50 Grabfood Digital Vouchers” PROMOTION

TERMS AND CONDITIONS

1. The following terms and conditions shall apply to the **NUTRISOY ONDEH ONDEH x 7E Win \$50 Grabfood Digital Vouchers** (“the Promotion”).

4. The Promotion is open to Singapore citizens, permanent residents and holders of valid employment passes or work permits, residing in Singapore.
5. Employees (and their immediate families) of F&N Foods Pte Ltd (“the Company”), F&N Interflavine Pte Ltd, their advertising and design agencies, distributors and promotional partners are not eligible to participate in the Promotion.

9. Winners will be selected based on the best answer(s) submitted, as determined by the Company panel of judges. **Winners will be notified by email**. Emails not acknowledged within two months from the date of notification email will be forfeited.
10. Winners must, upon request, provide the Company with all information necessary to facilitate the redemption of prize.

12. In the event of a dispute, the decision of the Company panel of judges is final. No correspondence will be entertained.
