

F&N x 7-Eleven “Win an APPLE AIRPODS MAX” PROMOTION

TERMS AND CONDITIONS

1. The following terms and conditions shall apply to the **F&N x 7-Eleven “Win a APPLE AIRPODS MAX” PROMOTION** (“the Promotion”).

8. Winners will be selected based on the best answer submitted, as determined by the Company panel of judges. **Winners will be notified by email.**
9. Winners must, upon request, provide the Company with all information necessary to facilitate the redemption of prize.
10. The Company reserves the right to amend or withdraw the rules and regulations without prior notice.
